This Release of Liability and indemnification shall apply to all known and unknown damages or costs resulting from the adoption, ownership or control of such animal(s). You hereby acknowledge, understand and agree with the above conditions and understand that this is a binding contract and if agreements are not met, is enforceable by civil law.
